



## History of Hutton Hill Rifle and Revolver Club

The Hutton Hill Rifle and Revolver Club, Inc. was organized in 1933 and has been affiliated with the National Rifle Association since 1935. The Club was first located in Voorhees Township, NJ 1933 to 1986 then relocated to the club's present location in Winslow Township, NJ in 1990.

It is a strictly private club with no obligations to any industry, municipality, or individual. Our Club is an all-around shooting club for all types of small arms shooting over standard courses of fire and separate ranges, which are independent and can be operated simultaneously. All of these facilities were financed by club members and built with club labor. Our club is affiliated with the National Rifle Association, Association of New Jersey Rifle and Pistol Clubs, and the New Jersey Federation of Sportsman's Clubs.

### Requirements for Membership:

1. Minimum of 18 years of age
2. Must possess a current and valid New Jersey Firearms I.D. Card for residents.
3. Must be a member of the National Rifle Association (If not a current member you will be required to join at the time of induction into the club. You are required to maintain your NRA membership as long as you are a member of Hutton Hill.)

There is a six-month probationary period, with a minimum of three visits required, during the induction period where you are permitted to shoot at the range as a guest, under the supervision of your sponsor. During this time you must be observed by two members of the executive committee, or twice by your sponsor and one executive committee.

### Dues Structure:

1. Current Dues are per year, including your NRA membership, \$100.00 of which is a refundable workday assessment fee to be returned to you upon completion of the required two (2) annual workdays. (Annual dues are set each year at the January General Membership meeting.)
2. The fiscal year starts April 1<sup>st</sup> and ends March 31<sup>st</sup>. (Dues are to be paid by May 1<sup>st</sup> when all lock combinations are changed.) After thirty (30) days a late fee will be assessed if dues are not received..
3. When submitting your membership application there is a onetime \$45.00 initiation & application fee. (The \$45.00 fee is refundable if you are denied entry into the Hutton Hill Rifle and Revolver Club, Inc.)
